## Charles Rice receives the Tommy and Susan Futral Inspiration of the Invitational Award at National Forestry contest in West Virginia

The 39<sup>th</sup> annual National 4-H Forestry Invitational was conducted Sunday July 29 through Thursday August 2. Teams from Alabama, North Carolina and Florida placed first, second and third, respectively. Arkansas, Georgia, Indiana, Kentucky, Louisiana Mississippi, New York, Oklahoma, South Carolina, Tennessee, Utah, and Wisconsin also competed in this year's Invitational.

Charles D. Rice received the Tommy and Susan Futral Inspiration of the Invitational award at the National 4-H Forestry Invitational at Jackson's Mill, 4-H Camp on August 1, 2018. Charles retired as the University of Georgia's Hart County GA Cooperative Extension Ag and 4-H Agent after 25 years of distinguished service. Over the years, Rice encouraged hundreds of Hart County 4-H'ers to study and compete in forestry. During his tenure, Hart County's 4-H forestry senior teams won the Georgia State Forestry competition and attended the National 4-H Forestry Invitational ten times. In 2011, his Georgia team placed first nationally. Charles also co-authored the Georgia Forestry Judging Handbook.

This quote was submitted Ruth Tellano-Daniel along with Charles' nomination for the award: I do not nominate Charles because of his success in his 4-H'ers winning awards, but because of his ability to inspire everyone around him to learn, persevere, and love forestry. The first time I attended the Invitational two years ago, I was shocked at the extent of Charles' influence on other state coaches and committee members over the years. Numerous people hurried over to tell me stories about Charles and his influence once he/she found out that I was from Georgia. He is an excellent ambassador of anything to do with forestry. He still helps coach and promote forestry in Hart County even though he retired four years ago.

The Tommy and Susan Futral Inspiration of the Invitational award recognizes an outstanding 4-H Forestry Invitational coach or 4-H Leader for their strong support of 4-H Forestry at the local, state and national level. Tommy and Susan were actively involved in 4-H Forestry for nearly 30 years. Their love for and contributions to the National 4-H Forestry Invitational are immeasurable. The Inspiration of the Invitational award was first presented in 2016 to Tommy Futral after Susan lost a long and courageous battle with cancer on October 22, 2015. The invitational was held at West Virginia University Jackson's Mill State 4-H Camp and Conference Center near Weston, West Virginia.
